Project #1 Dekker Centre RE: Artist Fee

COMMUNITY GRANT ALLOCATION- GRANT YEAR 2024/2025

#1 BE IT RESOLVED that the community grant request submitted by Eagle's Nest Youth Ranch Riverview be approved in the amount of \$1,362.38 to assist with the Punch Passes.

#2 BE IT RESOLVED that the community grant request submitted by Eagle's Nest Youth Ranch (1352 97th Street) be approved in the amount of \$1,497 to assist with the Punch Passes.

#3 BE IT RESOLVED that the community grant request submitted by Eagle's Nest Youth Ranch (10098 Hereford Street) be approved in the amount of \$1,497 to assist with the Punch Passes.

#4 BE IT RESOLVED that the community grant request submitted by Bready Elementary School be denied in the amount of \$500 to assist with the school rink.

Bready School applied for \$500 to support their skating rink, specifically for helmets, and related equipment. The request was deemed ineligible as the school had already received \$700 in funding earlier for a ski trip, exceeding the maximum allowable funding for educational purposes. The committee noted that funding could be eligible if directed towards community-related improvements, such as rink board replacements. The application was put on hold pending clarification from the grant adjudicator regarding eligibility for community-related expenses.

#5 BE IT RESOLVED that the community grant request submitted by Dekker Centre be approved in the amount of \$2,500 to assist with the Artist Fee.

The committee reviewed a funding request of \$4,700 for the performance *"Where Have All the Buffalo Gone"*, which is expected to benefit up to 700 children. Concerns were raised regarding the request exceeding direct deficit costs. Following discussion, partial funding of \$2,500 was approved.

#6 BE IT RESOLVED that the community grant request submitted by Notre Dame School be approved in the amount of \$700 to assist the Ski Program.

#7 BE IT RESOLVED that the community grant request submitted by Battlefords Tennis Club be denied in the amount of \$2,000 to assist in building Indoor Tennis Facility.

The funding request to build a facility does not meet the grant criteria, as construction, renovation, retrofitting, and repairs to buildings or facilities are ineligible.

UPDATES:

- Marnie Bull, the youth representative from SaKewew High School, was present at the meeting.
- The committee discussed the role and importance of a youth representative.
- Committee members discussed the committee's functions, emphasizing the importance of engaging younger demographics to ensure diverse perspectives.
- The inclusion of a youth representative was acknowledged as a step toward broader inclusivity and alignment with the committee's goals.
- Preliminary suggestions for the criteria and selection process for the youth representative were shared, with further details to be finalized in upcoming meetings.
- The community barbecues used to be spearheaded by a CPTED program (Crime Prevention Through Environmental Design), but since it no longer exists, the responsibility has shifted. Parks and Recreation staff are trying to manage it but are struggling with whether they're organizing these events effectively or if they should make changes.
- Director of Parks and Recreation Cheryl DeNeire expressed the need for community feedback on Parks and Recreation programs. She emphasized that some programs feel "stale" and repetitive, and there might be opportunities for the committee or community members to suggest changes or new ideas to keep programming fresh and relevant.
- Director of Parks and Recreation Cheryl DeNeire highlighted the importance of considering youth perspectives in planning programs and ensuring activities cater to their needs. This includes not only sports but also other areas of interest.
- Director of Parks and Recreation Cheryl DeNeire suggested that part of the advisory committee's role could include helping Parks and Recreation staff with long-term planning and brainstorming new ideas to ensure programs align with community need.
