



CANDIDATE CHECKLIST

- Verify you are qualified to hold office (citizenship, residency, etc.) and are not disqualified under *The Local Government Elections Act, 2015*, or *The Education Act*
- Decide which office you would like to represent (Mayor, Councillor, School Board Trustee)
- Review the City's *Candidate Criminal Record Check Bylaw No. 2162* and complete required forms with nomination package
- Review the City's *Campaign Disclosure & Spending Limits Bylaw No. 2167* and complete required forms
- Attend the SUMA Municipal Governance webinars on September 11th from 6:30-8pm and September 19th from 6:30-7:30pm
- Attend the Candidates Information Nights on Sept. 12th (Library) and Sept. 17th (Zoom) from 4:30-6:30pm.
- Note the requirements and deadlines for filing your nomination papers
- Appoint person(s) to act as your official agent(s), if desired, and file the appropriate forms with the Returning Officer
- Know the statutory requirements for election signage and which political activities are not permitted at voting places on Election Day, during advance polls, and during your campaign
- Familiarize yourself with the Voter Eligibility Requirements
- Ensure you are aware of advance, mobile, and special polls, and mail-in ballot information if you are asked by voters
- Note the name and contact information for the Returning Officer
- Promote the opportunity to vote on Election Day - Wednesday, November 13, 2024

DEFINITIONS

- a) **“private interest”** does not include an interest in a decision:
 - i. that is of general public application; or
 - ii. that affects a person as one of a broad class of persons.
- b) **“controlling interest”** means an interest that a person has in a corporation if the person beneficially owns, directly or indirectly, or exercises control or direction over shares of the corporation carrying more than 25% of the voting rights attached to all issued shares of the corporation.
- c) **“family”** means the spouse and dependent children of a member of a candidate.
- d) **“senior officer”** means the chair or vice-chair of the board of directors, the president, any vice-president, the secretary, the treasurer or the general manager of a corporation or any other person who performs functions for the corporation similar to those normally performed by a person occupying any of those offices.
- e) **“council, council committee, controlled corporation, or other body”** includes any committee or subcommittee of a committee, and any board, agency or commission, appeal board, or other body, on which a member of council serves in his or her capacity as a member of council.
- f) **“spouse”** means:
 - i. the legally married spouse of a person, with whom the person is cohabiting; or,
 - ii. a person who has cohabited with another person as spouses continuously for a period of not less than two years.
