**BYLAW NO. 2112**

**A BYLAW OF THE CITY OF NORTH BATTLEFORD IN THE PROVINCE OF SASKATCHEWAN TO AMEND BYLAW NO. 2107, BEING A BYLAW TO AUTHORIZE THE LEVYING OF A TAX RATE FOR VACANT COMMERCIAL PROPERTIES.**

WHEREAS Section 253 of *The Cities Act* provides authority for the Council to impose a levy on all taxable assessments; and

WHEREAS it is deemed necessary to amend the Bylaw that authorizes the levying of a tax rate for vacant commercial property with improvements within the defined Key Corridor area in the City of North Battleford.

NOW THEREFORE the Council of the City of North Battleford, in the Province of Saskatchewan, in open meeting assembled hereby enacts as follows:

1. Schedule "B" to Bylaw No. 2107 Vacant Commercial Properties with Improvements – Key Corridor, be deleted in its entirety and replaced by the following Schedule "B":
